



Terms and Conditions for MutCoin Airdrop

PLEASE READ THESE TERMS CAREFULLY. BY PARTICIPATING IN THE MUTCOIN (MTN) AIRDROP (AIRDROP), YOU AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS THEN DO NOT PARTICIPATE IN THE AIRDROP.

1. These terms and conditions (Agreement) apply to a promotional activity "MutCoin Airdrop" (Promotional Activity). This Promotional Activity aims to promote Waves Wallet (Wallet), Waves Client and Waves Platform, increase the number of users of these products, and make more people aware of their exciting uses. We are using this Promotional Activity as an opportunity to attract new members to the Waves community and encourage existing members to increase their engagement (Promotional Activity's goal). The Promotional Activity is organized and executed by Digital Finance Agency Ltd (Organizer, We) and will last from 14 June 2018 till 13 September 2018 (Period of Promotional activity).

2. The website of the Promotional Activity is <http://mutcoin.wavesplatform.com> (Website).

3. The MutCoin Airdrop's concept: 100,000 MutCoin (MTN) will be issued on Waves Platform and will be airdropped to the Wallets according to this Agreement. After the International Soccer Championship 2018 (ISC 2018) finishes, we will buy back all MutCoin (MTN) tokens for WAVES token via WAVES DEX at a rate (Buyback price) that depends on the results of Russian national team at ISC 2018.

4. There are two types of Airdrop: i) for the new Users (Airdrop 1), ii) for the Players and Coaches of the Russian national team (Airdrop 2).

5. **Rules for Airdrop 1 for the new Users.**

5.1. The new User will receive Airdrop 1, provided that:

5.1.1. The new User registers a new Wallet;

5.1.2. The new User follows Waves on Vkontakte (<https://vk.com/wavesplatform>) or likes Waves page on Facebook;

5.1.3. The new User joins the Waves Russian channel on Telegram (<https://t.me/WavesNewsRU>) or joins Waves News and Announcements channel on Telegram (<https://t.me/wavesnews>);

5.1.4. The new User submits the address of the newly created Wallet and their pages on social media using the form on the Website - <http://mutcoin.wavesplatform.com>.

5.2. The new User has the right to submit just one form (Application).

5.3. The Airdrop 1 will be delivered by the following formula: 1 new User = 1 Application = 1 MutCoin (MTN). If the new User registers several new Wallets and submits several Applications, they will receive only 1 (one) MutCoin (MTN).

5.4. The submissions will be accepted from 14 June 2018 till 28 June 2018. The Airdrop 1 will be delivered from 29 June 2018 till 15 July 2018.



5.5. We will accept 50,000 submissions and distribute 50,000 MutCoins (MTN) in total for Airdrop 1. All leftover MutCoins (MTN) will be burned after the Airdrop 1. Applications will be considered in order of priority based on the date of their submission. In addition, if one User has submitted more than one application, then for the purposes of the queue the last filed Application will be considered.

6. Rules for Airdrop 2 for the Players and Coaches of the Russian national team.

6.1. The Players and Coaches of the Russian national team (Player / Coach) will receive Airdrop 2, provided that:

6.1.1. The Player / Coach registers a new Wallet and sends us a letter via e-mail support@wavesplatform.com with their Wallet address.

6.1.2. The Player / Coach proves their identity. This process will be detailed upon receiving corresponding request in format of email.

6.2. The submissions will be accepted from 14 June 2018 till 15 July 2018. The Airdrop 2 will be delivered not later than 5 (five) working days after Player / Coach identification.

6.3. We will distribute 50,000 MutCoins (MTN) in total for Airdrop 2. Therefore, each Player or Coach may have the right to receive 1,785 MutCoins (MTN). All leftover MutCoins (MTN) will be burned after 15 July 2018.

7. After ISC 2018, Organizer will buy back MutCoins (MTN) according to the following rates:

7.1. If Russian national team becomes 4th in the group, Buyback price for 1 MutCoin (MTN) will be 0,1 (one tenth) WAVES token;

7.2. If Russian national team becomes 3rd in the group, Buyback price for 1 MutCoin (MTN) will be 0,25 (one twenty-fifth) WAVES token;

7.3. If Russian national team qualifies from the group, Buyback price for 1 MutCoin (MTN) will be 1 (one) WAVES token;

7.4. If Russian national team passes into the quarterfinals, Buyback price for 1 MutCoin (MTN) will be 2 (two) WAVES tokens;

7.5. If Russian national team passes into the semifinals, Buyback price for 1 MutCoin (MTN) will be 5 (five) WAVES tokens;

7.6. If Russian national team passes into the finals, Buyback price for 1 MutCoin (MTN) will be 7 (seven) WAVES tokens;

7.7. If Russian national team wins the ISC 2018, Buyback price for 1 MutCoin (MTN) will be 10 (ten) WAVES tokens.



8. In relation to Airdrop 1: MutCoins (MTN) will be bought back by us not later than 60 (sixty) calendar days after the end of ISC 2018, provided that Users submit a relevant order for selling MutCoin (MTN) on the WAVES DEX. Such an order shall be submitted within 55 (fifty-five) days after the end of ISC 2018. Otherwise, MutCoins (MTN) will not be bought back by us.

9. In relation to Airdrop 2: MutCoins (MTN) will be bought back by us not later than September 13, 2018, provided that Players or Coaches submit a relevant order for selling MutCoins (MTN) on the WAVES DEX. Such an order shall be submitted not later than September 10, 2018. Otherwise, MutCoins (MTN) will not be bought back by us.

10. There are no fees associated with participation in the Airdrop.

11. The Organizer reserves the right to suspend or terminate the Promotional activity or change the terms of this Agreement at any time, if in Organizer's reasonable view some Users is unfairly exploiting the opportunities of the Promotional Activity.

12. The Organizer reserves the right to refuse to deliver the Airdrop to the specific User, if in Organizer's reasonable view this User is unfairly exploiting the opportunities of the Promotional Activity.

13. The tax characterization of Airdrop is uncertain. The User, Player, and Coach must seek its own tax advice in connection with receiving Airdrop, which may result in tax consequences to the User, Player, and Coach including withholding taxes, income taxes and tax reporting requirements.

14. The User confirms:

14.1. The User has full capacity and authority to enter into this Agreement;

14.2. The User follows the rules and laws in his/her country of residence.

15. In no event shall the Organizer be liable for any direct, indirect, punitive, incidental, special or consequential damages arising out of or in any way connected with the use of the Wallet, the delay or inability to use the Wallet or otherwise arising in connection with the Wallet whether based on contract, tort, strict liability or otherwise, even if advised of the possibility of any such damages.

16. User agrees to defend, indemnify and hold the Organizer harmless from and against any and all claims, damages, costs, and expenses, including attorneys' fees, arising from or related to User's use of the Wallet.

17. Use of information. By participating in the Promotional Activity, the User, Player, and Coach agree to the collection and use of its personal information by the Organizer in accordance with this Privacy Policy (<https://mutcoin.wavesplatform.com/wp-content/uploads/Privacy-Policy.pdf>). If the User, Player, and Coach do not agree to the terms of this Privacy Policy, they shall not provide the Organizer with any information and participate in the Promotional Activity.

18. Disputes arising between the parties under this Agreement or in connection with it shall be settled in the course of pre-court dispute settlement procedure.



19. In the case of failure to settle the dispute within 30 (Thirty) calendar days from the date of the direction of the claim to one of the parties, the dispute shall be resolved in accordance with the applicable law.

20. The Agreement and any legal relationship between the Parties arising out of or in connection with them shall be governed by and construed in accordance with the laws of England and Wales without regard to its conflict of laws rules. The Parties settle all their disputes arising out of or in connection with the Agreement in accordance with the laws of England and Wales.
